

**NOTE:** \*This paper comprises of two parts, one viva voce examination on cumulative internship of twelve weeks and moot courts examination. Student has to prepare a record of atleast three moot courts which he has participated and presented in this semester. Out of these three he will be ask to present one moot court by the external examiner at the time of viva-voce examination. Total 100 marks shall be distributed as under –

- 30 marks for written work of moot courts record and internship diary.
- 30 marks for vivo voce examination on internship.
- 40 marks on presentation of moot courts.

**Note:** Wherever an option has been given for a student to choose a subject under this scheme, the student will have to choose any one subject from amongst the options provided under this scheme. Also, once a student has chosen a particular subject, he/she will not be allowed to change the optional subject at any later point.

### **B.A.LL.B. FIVE YEARS COURSE - ELIGIBILITY CRITERIA FOR ADMISSION**

Rules of Promotion from one semester to another semester are as follows:

**From I to II -** A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-I.

**From II to III -** a) A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-II, and; b) the number of backlogs, if any, of Semester I and II taken together shall not exceed 5(five) courses/papers prescribed for Semester I and II.

**From III to IV** - A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-III.

**From IV to V:** a) A Student Should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-IV, and; b) A Student must have passed all the papers/course of

Semester I and II, and; c) the number of backlogs, if any, of Semester III and IV taken together shall not exceed 5 (five) courses/papers.

**From V to VI -** A Student should have undergone regular course of study and appeared for Sessionals or / and University Theory / Practical Examination of Semester-V



## **RULES OF PROMOTION**

### **FIVE YEAR COURSE**

Rules of Promotion from one semester to another semester are as follows:-

**From I to II -** A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-I.

**From II to III** - a) A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-II, and; b) the number of backlogs, if any, of Semester I and II taken together shall not exceed 5(five) courses/papers (50 %) prescribed for Semester I and II.

**From III to IV** - A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-III.

**From IV to V** - a) A Student Should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical Examination of Semester-IV, b) the student must have passed all the papers/courses prescribed for Semester I and Semester II examination, and c) the number of backlogs, if any, of Semester III and IV taken together shall not exceed 5 (five) courses/papers(i.e. 50% of papers prescribed).

**From V to VI -** A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory Examination of Semester-V

From VI to VII - a) A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory Examination of Semester-VI; and b) The student must have passed all the papers/courses prescribed for Semester I to Semester IV examinations; and c) The number of backlogs, if any, of Semester V and VI taken together shall not exceed 5 (five) courses/papers (i.e. 50% of papers prescribed)

**From VII to VIII -** A Student should have undergone regular course of study and appeared for Sessionals or/and University Theory/Practical/Clinical Examination of Semester-VII 5

From VIII to IX - a) A Student should have undergone regular course of study

and appeared for Sessionals or/and University Theory/ Practical/Clinical Examination of Semester-VIII; and b) A Student must passed all the papers/course of Semester I to Semester VI; and c) The backlogs, if any, of Semester VII and VIII taken together shall not exceed 5 (five) courses/papers. (i.e. 50% of papers prescribed).

From IX to X - a) A Student should have undergone regular course of study and appeared for

Sessionals or / and University Theory / Practical / Clinical Examination of Semester-IX

**Note:** Wherever an option has been given for a student to choose a subject under this scheme (whether law/pre-law subject), the student will have to choose any one subject from amongst the options provided under this scheme. Also, once a student has chosen a particular subject, he/she will not be allowed to change the optional subject at any later point.



- **1. DURATION OF THE PROGRAMME**: The duration of the LL.M programme shall be TWO academic years spread over FOUR semesters with the University Examinations at the end of each Semester. Successful completion of this course would lead to the award of Master of Laws (LL.M.) degree.
- **2. ELIGIBILITY CRITERIA FOR ADMISSION:** An applicant for admission to LL.M programme should have obtained Bachelors Degree in Law (LL.B.) Nagpur with 50% aggregate marks.
- **3. MEDIUM OF INSTRUCTION AND EXAMINATION:** The medium of instruction and Examination for LL.M Course shall be English.
- **4. ATKT RULES :** The admission of students to the LL.M course/program shall be on the yearly basis. Therefore, a student admitted to the FIRST semester and who undergoes the regular course of study of FIRST semester, certified by the head of the Institution where he/she is admitted, shall be allowed to be promoted to the SECOND semester without any condition. In order, however, to be eligible to be admitted to the THIRD semester, the student should have passed in atleast 50% (Fifty Percent) of the total number of Papers / subjects / courses of the

First and the second semester taken together.

The student taking admission to the THIRD semester in terms of the above clause shall be entitled to be promoted to the FOURTH semester without any condition.

**5. CRITEROIN FOR PASSING:** In order to be successful at the examination and to be eligible for the Degree of Master of Laws under, an examinee shall obtain a minimum of 40% marks in each paper and obtain 50% marks in aggregate to be declared successful.

The candidates will have to prosecute regular full time course of study. For every theory paper/course the total marks will be 100 out of which 20 marks are for internal assessment and 80 marks are for university theory examination. However the passing marks in each subject will be calculated by combining the marks scored in the internal assessment and the university theory examination for the concerned subject. (i.e. to say Passing Marks = University theory + internal assessment = 40%).

For being eligible for exemption in a paper, a candidate should obtain minimum 50% of marks in that paper.

Theory papers and practical examination is independent passing heads.






